It is to inform you that the list of candidates selected for Central Sector Scheme of scholarships for college & university students for the year 2008-09 of your college is enclosed herewith. In case where the students get equal total marks, marks obtained in Physics, Chemistry and English (for Science stream), Commerce, Economics and English (for Commerce stream), in the order of preference are taken into consideration for final selection of the candidates.

A part of the scholarship amount is now released and transferred / under transfer to the bank account of the students, and the balance amount as well as the renewal amount for 2009-10 will be released / disbursed by M.H.R.D. G.O.I. New Delhi.

You are requested to bestow your personal attention for effective implementation of the scheme by adhering to the following guidelines.

- 1) The candidate shall not avail any other scholarship which do not include fee reimbursement. The candidates who have already received scholarship from Government of A.P. or any Government Agency during 2008-09 should refund the same to the concerned Government / Agency through challan under concerned head of account and a copy of the same may be sent to this office.
- 2) Scholarship amount is being transferred online directly to the Bank Account of the students as furnished in the application. Those candidates who did not furnish Bank A/c No. in the application, or who furnished Bank Account Nos. which do not have online facility have to be advised to open Account in any bank which has online facility and the particulars should be sent to this office in the following format.

- 3) Blank renewal application forms which are sent herewith may be filled by your office for each individual student as per the sanction list and the same may be sent for renewal of scholarship for the year 2009-10 by your office for the students who fulfill the following conditions.
 - i) The candidates should be promoted to next class and secure atleast 60% marks in the first year bachelor degree course.
 - ii) The candidates should putin 75% of attendance in the respective academic years & should have good behaviour / conduct.
